WHAT EXACTLY IS COMMODITIES COACH PHONE ALERTS?

Commodities Coach is a private trade recommendation service reserved exclusively for clients of Steve Dahl, seasoned commodities trader with Daniels Trading in Chicago. With a decade of day in and day out trading experience, Steve reveals how a commodities insider trades right before your eyes (or should we say ears).

HOW ARE THE RECOMMENDATIONS TRANSMITTED?

As the name suggests, this one-of-a-kind advisory delivers timely trade recommendations accessible to clients by telephone. As new opportunities arise during the trading session, Steve records live “Voice Broadcasts” that provide the inside scoop on his commodities trading recommendations. Clients are alerted via email (and soon mobile text message) when a new Voice Broadcast is awaiting them. Simply call the convenient toll-free number to listen in. With one easy push of a button clients can connect directly to Steve’s brokerage office for immediate order placement and hands-on assistance with the strategy. However, if you decide after listening to the recommendation that you prefer to stay on the sideline, simply hang up. This “no-hassle” service keeps you in control every step of the way.

WHAT PRODUCTS DOES THE SERVICE TRADE?

Commodities Coach offers trade recommendations for commodity futures contracts and commodity options. Clients may specify in advance if they prefer to receive recommendations for futures, options, or both. Commodities Coach aims to provide strategies targeted to your trading interest.

HOW LONG DO THE VOICE BROADCASTS LAST?

Commodities Coach realizes that your time is valuable so all Voice Broadcasts are kept under 2 minutes.

WHAT IS “ASK THE COACH” MAILBAG?

This is a valuable Question & Answer opportunity for clients to expand their trading knowledge and learn from fellow traders. Ask The Coach mailbag is published by Commodities Coach via email in a bi-weekly issue. Clients can simply email questions on any trading related topics to AskTheCoach@danielstrading.

com and “The Coach” may address in the next mailbag update. Most often “The Coach” prefers that the entire team is able to learn from the questions so whenever possible they are addressed publicly in the mailbag (unless private in nature, of course).

HOW MANY RECOMMENDATIONS CAN I EXPECT?

Typically each month Commodities Coach provides around 5-15 recommendations for futures contracts. The trade duration on futures trades is most often 1-4 days. Commodities Coach also provides 1-2 options trading strategies during most months and the duration is 3-12 weeks.

HOW DO THE STRATEGIES MANAGE RISK?

Every futures trading recommendation has a pre-determined stop loss (typically \$200-600 risk), thus triggering a liquidation of the position if the strategy reaches the risk tolerance. The options strategies trade only on the long side (we are buyers only, not “writing” options) so the maximum loss is the premium cost paid at purchase. This is typically between \$300-1500.

WHAT DO I NEED TO RECEIVE THE SERVICE?

All that is required to receive these private strategies is an active funded account with Steve Dahl and a telephone of course. An email is necessary to receive electronic updates.

WHEN DO THE ALERTS COME OUT?

Most of the trade recommendations are released during regular day session trading hours. However, exactly what time alerts come out during the day are variable and a function of the market. The market rarely provides advance notice when there is an opportunity.

HOW MUCH DOES COMMODITIES COACH COST?

The service is 100% free to clients. Commodities Coach Phone Alerts is aimed at inspiring your trading, not generating subscription fees. In fact, these strategies are not available to the public for purchase.

IS THERE A MINIMUM ACCOUNT BALANCE TO PARTICIPATE?

There is no minimum account balance required in order to receive Commodities Coach Phone Alerts.
