Settlement	Cash settlement based on the Final Settlement Price, payable on the first exchange trading day following the Last Trading Day.
Price Quotation	1 point
Minimum Price Change	1 point, equivalent to a value of EUR 10.
Contract Months	The three successive quarterly months within the March, June, September and December cycle.
Last Trading Day	The third Friday of each contract month, if this is an exchange trading day; otherwise, the exchange trading day immediately preceding that Friday. Trading in the maturing futures contract ceases at 9:10 CET on the Last Trading Day.
Daily Settlement Price	The closing price determined within the closing auction; if no price can be determined in the closing auction or if the price so determined does not reasonably reflect the prevailing market conditions, the daily settlement price will be the last traded price within the last 15 minutes of continuous trading. If the last traded price is older than 15 minutes or does not reasonably reflect the prevailing market conditions, Eurex will establish the official settlement price.
Final Settlement Price	The value of the Dow Jones Italy Titans 30 SM Index Future is determined on the basis of the collective Borsa Italiana opening prices of the shares contained in the Dow Jones Italy Titans 30 SM Index on the Last Trading Day.
Trading Hours	From 9:00 to 17:40 CET.

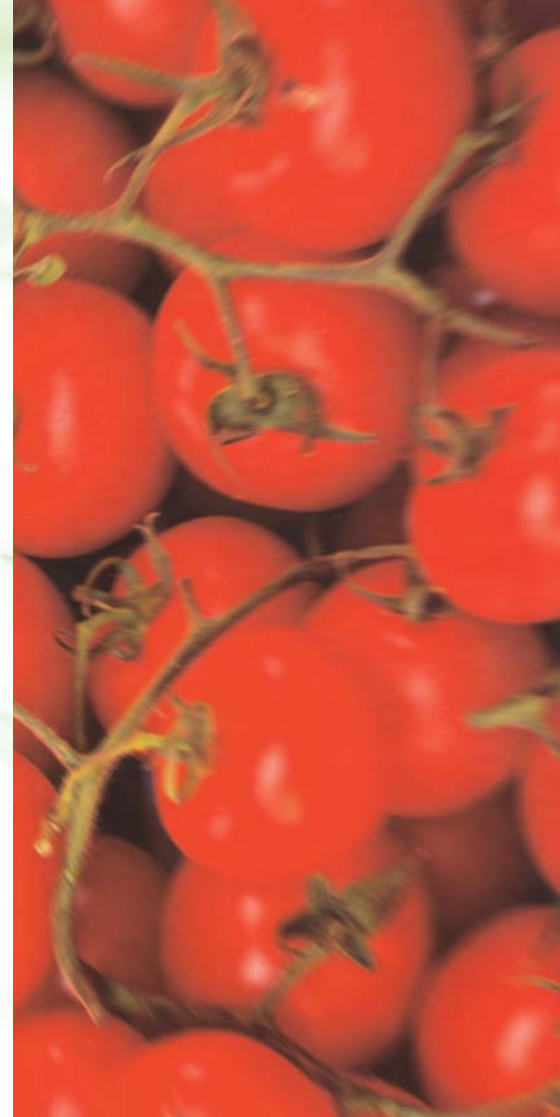

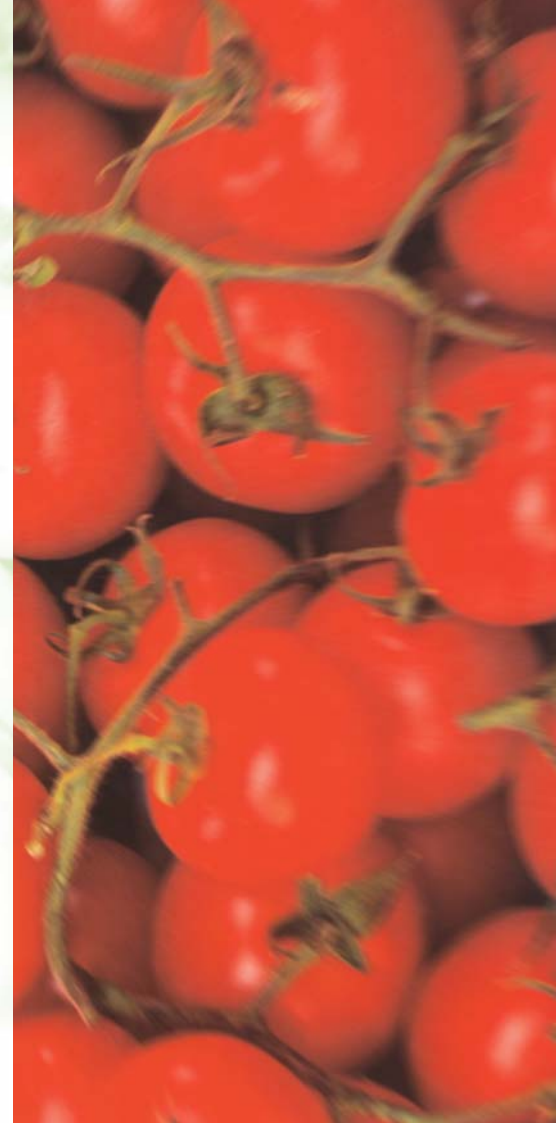
